Speaker biographies



The Hon. (Brad) Bradley Ronald Hazzard MP

Brad Hazzard is the Minister for Family and Community Services and the Minister for Social Housing in the NSW Liberal & Nationals Government.

Brad started his professional life as a graduate science teacher. He later studied law at the University of NSW and was admitted as a solicitor in 1977. In 1984 he was awarded a Master of Laws from the University of Sydney. Brad practised as a solicitor and arbitrator. He entered Parliament in 1991 as the State Member for Wakehurst on Sydney's Northern Beaches. As Minister, Brad has been tasked to drive the NSW Government's policies to safeguard the most vulnerable members of our community and address the cycle of disadvantage.

Before his appointment as Minister for Family and Community Services and Minister for Social Housing in April 2015, he was the Attorney General and Minister for Justice. Prior to that he served as Minister for Planning and Infrastructure, Minister Assisting the Premier on Infrastructure NSW and Leader of the House in the Legislative Assembly.



Robynne Quiggin

Robynne Quiggin is a Wiradjuri lawyer, based in Sydney. She has worked across a number of legal and policy areas of relevance to Indigenous Australians including consumer issues, human rights, governance, the arts and heritage. She is currently the Deputy Aboriginal and Torres Strait Islander Social Justice Commissioner at the Australian Human Rights Commission. Robynne has served

on a number of boards including the Arts Law Centre of Australia, Bangarra Dance Theatre, and is the chair of Westpac's Reconciliation Action Plan Committee.



Professor Mark Courtney

Mark E. Courtney is a Professor in the School of Social Service Administration at the University of Chicago. His fields of special interest are child welfare policy and services, the connection between child welfare services and other institutions serving families living in poverty, the transition to adulthood for vulnerable populations, and the professionalisation of social work. Dr. Courtney is a Fellow of the American Academy of Social Work and Social Welfare. Dr. Courtney received the 2015 Distinguished Career Achievement Award from the Society for Social Work and Research. Dr. Courtney has served as a consultant to the federal government, state departments of social services, local public and private child welfare agencies, and the philanthropic community.
